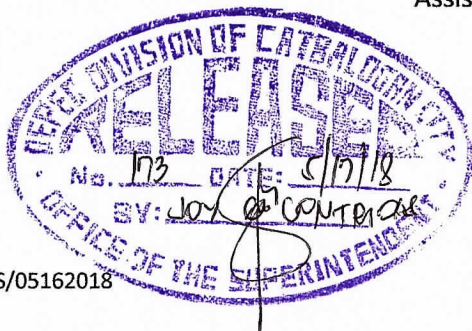

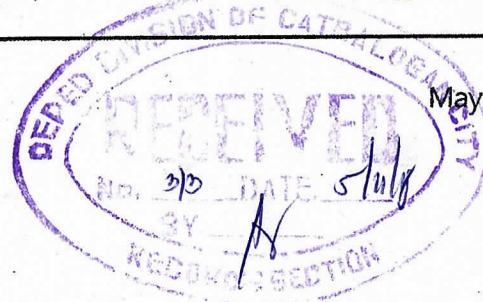



The Department of Education, Regional Office No. VIII through the Quality Assurance Division (QAD) announces the **CLOSURE** of **HINDANG PARISH LEARNING CENTER, INC.**, Area 5, Leyte Division, Region VIII with **school ID No. 404672**, effective SY 2018-2019. The closure of the school is thru voluntary withdrawal of Recognition under section 34 of DepEd Order No. 88 s. 2010 per communication received from Miguela A. Pil, school administrator and indorsed by the Schools Division Superintendent of Leyte Division. Said school administrator is a 90 years old, lone survivor from among the Board of Trustees, who finds it difficult to manage the school due to health condition.

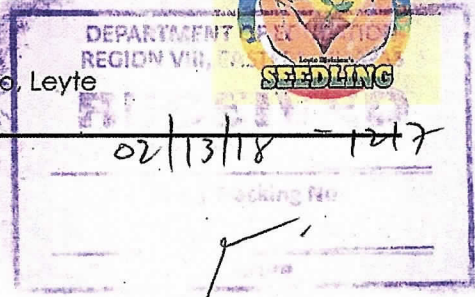

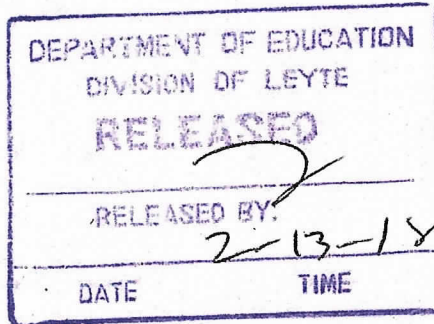
